Public Consultation

The majority of the meeting was given over to the draft results of the public consultation exercise. There was a response rate of over 30%. This was thought to be very good, meaning the results have more weight.

RR advised that the young peoples responses had yet to be collated and analysed but would be included as a separate chapter. RR also expressed disappointment with the response from business – with only 6 surveys returned. RR hopes to have another attempt at this in coming months.

SS enquired about the list of people who agreed to be contacted again in future. It was suggested that they be invited to a public meeting to see the results of the survey and to participate in a work shop type event to set up the theme groups to start working through the issues.

CH to book small room in Camelford Hall for an evening meeting.

AS requested that the 'Verbatim Comments' be rationalised in some way, possibly into themed groups. RR to action

AS thanked RR and his staff for their work. RR has volunteered to join the Steering Group, as a resident, now that PFA's input is coming towards the end. The Steering Group were very happy to have RR's continued input into the process.
