6. To receive Clerk's report

Shared prosperity fund bids – Community Levelling Up Fund bid in for £54k – more likely to be £60k once the quotes have been updated, potential of about £10k available from the Accelerator fund. Registering community assets. CCTV – monitoring in Bude – passive; would only dial in if there was an issue/Police asked them to. Clerk will investigate further. SWARCO – heads of terms negotiation completed and with solicitors. Hoping installation in February so it can be energised by Easter. Will include electricity for ticket machine, but will need to keep the old one going over the winter. Clerk noted recent conversations with CC Officers regarding the bypass. CC is forwarding additional information to DofT next month. DofT is still working out what the PM statement means in reality for other projects – hope to have an answer by Christmas. CC has spent approx. £2.4m of the £6.6m which was allocated to the project. There isn't a new business plan – addendums are being added to the original as DofT asks for addition information.
