7. **To receive Clerk's report**
Line painting was completed on 11th July in Churchfield Car Park. The EV Chargers and Ticket machine are due to be connected to the mains and powered up in the next couple of weeks following the signing of the Wayleave document included in this meeting. Clease Road car park line painting was completed on 8th July- new signage and permits have been ordered. Permits will be available to purchase in the Library from Monday 22nd July- one permit per household available for residents of Fore Street, High Street and Chapel Street. Awaiting quotes for Broadwood bridge repairs but so far indications are that costs will be above £30,000, clerk to investigate different funding options. Regarding the Road closure on the A39- Clerk went out to talk to local businesses, concerns were raised around Mill Lane and Back Street due to dangerous driving- Clerk passed these concerns on to Highways to investigate- no further news from Cornwall Council regarding the progress on the unstable building. Incident in Enfield park- child got knees stuck through railings on play equipment- member of public cut them free, a temporary fix has been put in place to make it safe- Clerk to check ROSPA report. 8. **To receive Grounds Manager's report (MGM)**
Broadwood bridge- A discussion took place around whether or not to remove the slats on the bridge to prevent members of public accessing the bridge- The committee agreed that blocking the bridge with fixed timber barricade along with the signage we have put up is sufficient. Himalayan Bolsum is coming into the park- Groundsmen trying to stay on top of this but more letters will need to be sent to the properties on Mill Lane as it is present in some of the gardens. MGM has enquired around quotes for self-binding gravel for the path around the pond- A discussion took place around the urgency for this as it has not been budgeted for in this financial year. It was agreed to move this discussion for budget chats in September. Weed killer has been ordered for Gravel at Cemetery and the Cobbles on market place - This prompted a lengthy discussion around weed killer usage which new clerk had not been privy to previously. Weed killer is to only be used as a last resort- Cllr Hewlett to send MGM information on salt & Vinegar mix to try first. The rail at Clease Road car park has been temporarily fixed, MGM purchasing necessary parts to complete the work. Cemetery – MGM now has PPE to wear to enable strimming near Bee Hives. A lengthy discussion took place regarding the mowing required in the Orchard. It requires a full cut, but resources and time management are an issue. EP/24/043
